

Tuition Payment Estimator

This Tuition Estimator is provided to students to use as an informational budgeting tool; it is not an invoice. Tuition estimates are for the entire program. Tuition rates vary depending on courses and credits taken in an academic year; student fees are calculated based on program enrolment and program completion time. Student will be emailed monthly invoices detailing specific tuition and fees due based on current/actual enrolments and program of study.

Tuition Deposit:	Note: The tuition deposit is paid on acceptance into the program and is a pre-payment of tuition and will be automatically applied to the first invoice either by course based or full year payment options.	
Payment Options: Full Year/Program or Monthly	Option 1: Full Year Payment Option	An estimated full year amount will be calculated for each program; students choosing to pay each year in full will have the annual installment fee waived. Programs with a duration of 12 months or less will calculate a full program amount.
	Option 2: Monthly Payment Option	Invoices will be issued monthly on the 1st of the month prior to each course start date and due on the 21st of the month of each course start date. An annual installment fee applies for students choosing the monthly payment option.

Additional ancillary fees may also apply for program completion plans that extend past normal completion time.

The University is not bound by any estimated program tuition provided. In the case of discrepancy between an estimate and an invoice; the invoice will prevail.

All tuition and fees are invoiced based on individual student enrolments, any changes to enrolments, credit load, electives, or program duration may result in additional or increased fee rates.

Additional ancillary fees may apply depending on completion option chosen or change in program duration or delivery method and will be invoiced in addition to fees outlined above.
