Programs with a duration of 12 months or less will calculate a full program amount.
	Option 2: Monthly Option	Invoices will be issued monthly on the 1st of the month prior to each course start date and due on the 21st of the month of each course start date. An annual installment fee applies for students choosing the monthly payment option.
