**Dissertation Invoicing Schedule MGMT799/790	Dissertation invoicing starts 30 days prior to the start date of MGMT790. The Candidacy Exam MGMT799 and the Dissertation MGMT790 are bundled together for invoicing purposes as students are considered active in the Dissertation phase of their program during the candidacy exam process. The Dissertation bundle invoicing is spread over 3 calendar years into 12 installments; if the Dissertation is completed prior to full invoicing, the remaining installments will be issued and due at that time.
