Tuition Deposit:	Note: The tuition deposit is paid on acceptance into the program and is a pre-payment of tuition and will be automatically applied to the first invoice either by course based or full year payment options.	
Payment Options: Full Year/Program or Monthly	Option 1: Full Year Payment Option	An estimated full year amount will be calculated for each program; students choosing to pay each year in full will have the annual installment fee waived. Programs with a duration of 12 months or less will calculate a full program amount.
	Option 2: Monthly Payment Option	Invoices will be issued monthly on the 1st of the month prior to each course start date and due on the 21st of the month of each course start date. An annual installment fee applies for students choosing the monthly payment option.
